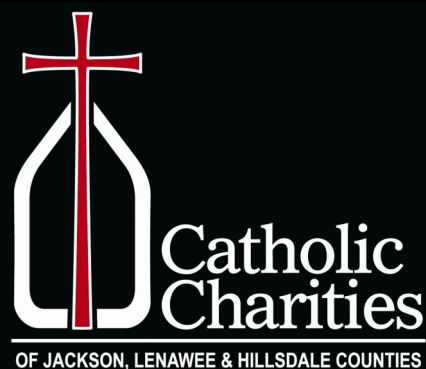

## 2017 Program Highlights

**Counseling Services:** Over 13,400 sessions of mental health and substance abuse counseling.

**School Counselor:** Provided part-time counselor in four Catholic elementary schools.

**Foster Care:** 50 children were served; 10 new foster homes were licensed, with average of 28 licensed homes; 7 children were reunited with their families.

**Adoption:** 21 children were given "forever families" through adoption.

**Child Advocacy Centers:** Completed over 250 forensic interviews for abused children.

**Roadmap to Graduation:** 4 homeless students were provided mentor homes; 2 who were Seniors were able to graduate successfully.

**Senior Transportation:** Volunteer drivers helped 139 seniors to over 2,000 medical appointments.

**Prison Based Services:** Provided substance abuse counseling services in 6 prisons across Michigan.

## FROM THE EXECUTIVE DIRECTOR

Dear Friends of Catholic Charities,

For nearly 60 years, the mission of Catholic Charities has called us to care for the most vulnerable among us and to transform lives and communities through **providing help and creating hope**. Our vision for 2018 is to continue to transform lives of those who need us most.

One of our best examples in caring for the most vulnerable, is in the celebration of the opening of our second Child Advocacy Center in 2017. Who needs us the most? The children. Children who have been victims of sexual and severe physical abuse. By the end of the year, our Child Advocacy Center in Jackson County had conducted 231 forensic interviews for children. Although the Lenawee County Child Advocacy Center just opened in November 2017, we are well on our way to reaching similar numbers in the years ahead. The numbers speak for themselves and it is our responsibility as disciples of Jesus Christ to help those in need. Whether it be child victims of sexual abuse, homeless teens, the imprisoned, seniors in need of transportation to medical appointments, providing a loving home for foster children, helping those addicted to drugs and alcohol, or offering support to those who have just lost a loved one, Catholic Charities continues to welcome all of God's children with open arms.

We never could accomplish what we do year after year without our dedicated staff and volunteers, or the generosity of our donors, foundations, and other funding sources. As we head into our 60<sup>th</sup> year, on behalf of all of us at Catholic Charities of Jackson, Lenawee and Hillsdale Counties, we thank you and invite you to partner with us in our mission of transforming lives.

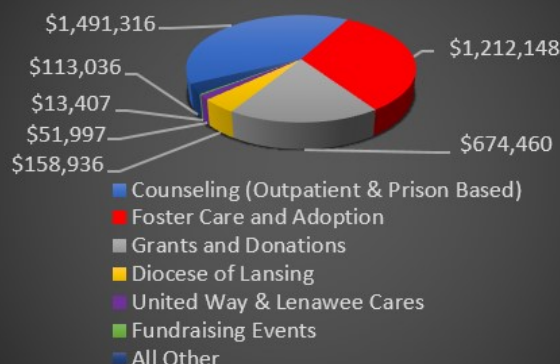

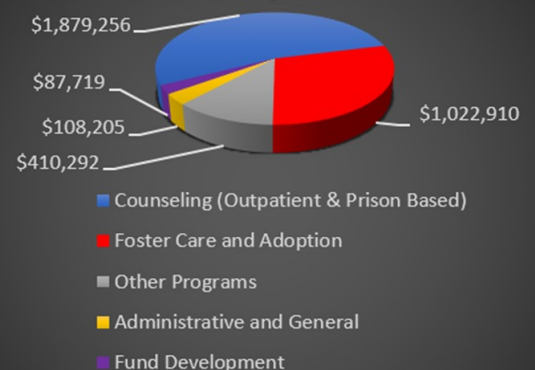

### 2017 Expenses



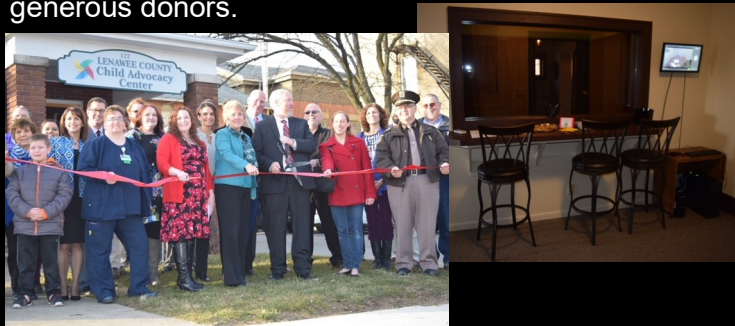


# 2017 Agency Highlights



The opening of the **Lenawee County Child Advocacy Center** in Adrian, MI means children

who are victims of abuse can be served close to home in our child-friendly environment. This program is an important collaborative effort with several community agencies and is the culmination of several years of effort from volunteers, staff, local law enforcement, and generous donors.



Our **Bags of Hope** program was launched to help supplement our local Catholic Food Pantries in Lenawee and Hillsdale Counties. The service project offers a volunteer opportunity for groups to get involved by shopping for personal needs items (toilet paper, shampoo, toothpaste, etc.) for distribution through the participating pantries.

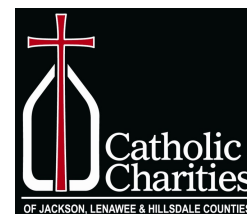

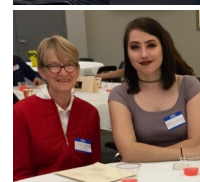
