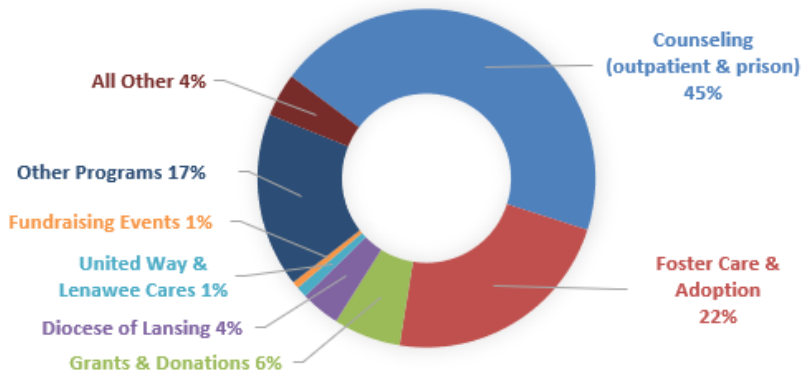

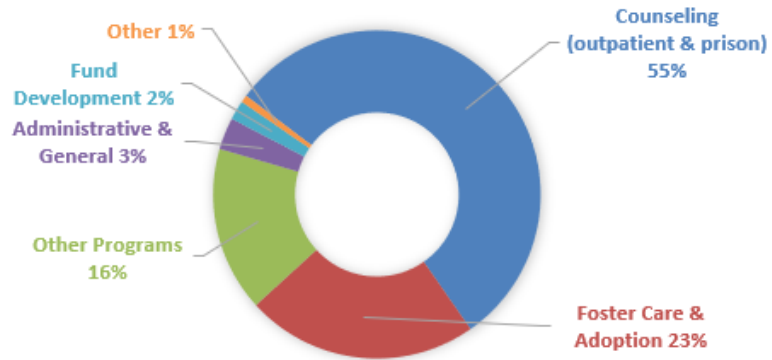

2019 Program Highlights

Counseling Services:

Over 9,120 sessions of mental health and substance abuse counseling.

School Counselor:

Provided a School Counselor in all Catholic schools in our area.

Foster Care:

70 children were served in our 35 foster homes; 12 children were reunited with their families.

Adoption:

32 children were given "forever families" through adoption.

Child Advocacy Centers:

Completed 476 forensic interviews for children alleged to be abused; victim advocacy and counseling provided for the children served.

Roadmap to Graduation:

Two homeless students were provided mentor homes and graduated.

Senior Transportation:

Volunteer drivers helped 125 seniors to 1,683 medical appointments, traveling 34,000 miles.

Prison Based Services:

Provided substance abuse counseling services in 7 prisons across Michigan.

Because of the generosity of many skilled quilters, we have distributed over 400 *Comfort Quilts* to child victims of abuse through our Child Advocacy Centers.



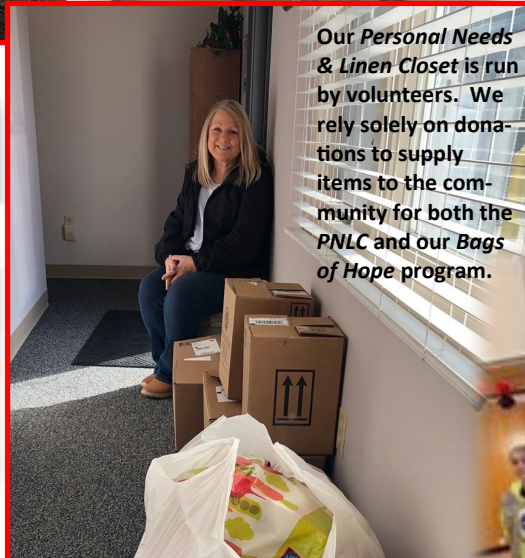
We rely on volunteers to help with maintenance work and projects like our Foster Care Playground.

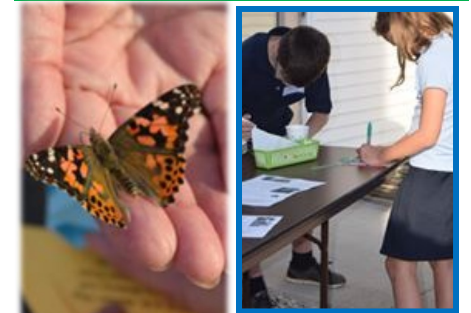
The first phase of our expansion project at our **Jackson County Child Advocacy Center** was kicked off in April.
