

Legacy Giving

What is Legacy Giving (Planned Giving)

Legacy giving or planned giving is a philanthropic approach to supporting your favorite nonprofit organization through a transfer of assets as part of an estate plan or bequeathed through a will. These assets include cash assets, real estate, stock, and life insurance to name a few. This forward-thinking approach to giving is "planned" because a donor's assets are often not liquid, being used to generate income, wrapped up in a business, and/or have current tax limitations or consequences if accessed. Legacy giving provides many tax benefits that can benefit you now or in your future estate.

In short, legacy giving is a deferred form of individual giving.

It's Not All or Nothing

Legacy giving can work in tandem with other family priorities; it is not an all-or-nothing bequest. These gifts can co-exist with other beneficiaries and personal priorities. If you prefer, your gift can be based on percentages rather than a lump sum.

Legacy Giving Options

A bequest through your will or trust is one of the most popular and flexible ways that you can support Catholic Charities. A beneficiary designation gift is a noble alternative to a traditional bequest; it's a simple and affordable way to make a gift to support Catholic Charities. You can designate us as a beneficiary of a retirement plan, investment or bank account, or your life insurance policy.

Sample Legacy Giving Verbiage

There are many ways you can bequeath funds to Catholic Charities. You can designate a lump sum, a percentage, residuary designation, or contingency bequest. Below are simple verbiage examples that can be considered for your will, trust, or an amendment to your existing will or trust.

SPECIFIC GIFT

"I give, devise, and bequeath to Catholic Charities of Jackson, Lenawee and Hillsdale Counties, a Michigan 501(C)(3) organization, the sum of _____ dollars (\$_____)."

SPECIFIC PERCENTAGE

"I give, devise, and bequeath to Catholic Charities of Jackson, Lenawee and Hillsdale Counties, a Michigan 501(C)(3) organization, an amount equal to ______ percent (____%) of the value of my estate at the time of my death."

RESIDUAL BEQUEST

"I give, devise, and bequeath all of the residue of my estate, both real and personal, to Catholic Charities of Jackson, Lenawee and Hillsdale Counties, a Michigan 501(C)(3) organization."

CONTINGENT BEQUEST

"If the above-named beneficiaries should predecease me, then I hereby give and bequeath all of my property and estate to Catholic Charities of Jackson, Lenawee and Hillsdale Counties, a Michigan 501(C)(3) organization."
